Question 1

Every day, The Salvation Army works with individuals in Scotland who are consuming alcohol and are experiencing associated harms. It is through this work that we witness first-hand the devastating effect alcohol dependency can have on individuals and their friends and families.

Prior to the MUP policy being introduced in Scotland, The Salvation Army was particularly concerned by the fact that alcohol was available for 14 p per unit in some areas of Scotland 1. This type of cheap alcohol tended to be purchased by harmful drinkers (including young, underage drinkers), with evidence suggesting that the alcohol consumption of the heaviest drinkers will also be affected by price 2. The Salvation Army remains concerned that, should the policy not continue, these exceptionally low prices could return, along with an increase in associated harms.

The Salvation Army has been greatly encouraged by the benefits associated with the introduction of the MUP policy in 2018. The Salvation Army is particularly encouraged by the evaluation analysis which indicated MUP was associated with a 13.4% reduction in deaths wholly attributable to alcohol consumption 3. These findings mirror that of previous research by Sheffield University which shows that as alcohol becomes more affordable, the number of alcohol-related deaths and hospital admissions increases 4.

These findings show that Minimum Unit Pricing can make a difference and help save lives. It is with this in mind that The Salvation Army reiterates its support for Minimum Unit Pricing.

Question 2

Whilst The Salvation Army is not expert in this level of economic modelling, we do believe that should the policy continue, it should be on the basis of saving as many lives as possible within realistic consumer terms.

With this in mind, The Salvation Army supports the introduction of the 65 pence price.

However, The Salvation Army also acknowledges that the price level will have a varying impact depending on external factors, such as inflation. The Salvation Army therefore advocates that the minimum unit price is set by secondary legislation to enable ministers to vary the price as circumstances change.

Question 3

The Salvation Army is clear that this policy itself is not a silver bullet for addressing alcohol related deaths or harms. The Salvation Army is clear that action needs to incorporate increased access to support services that help tackle the reasons why people have turned to alcohol in the first place.

However, The Salvation Army believes that Minimum Unit Pricing still has a role to play within a wider set of policies and action aimed at reducing alcohol-related harms.

The Salvation Army acknowledges that within the framing of this consultation, the Scottish Government has made clear that this measure should to be enacted within a context of wider support: "MUP alone was not intended to address the needs of this group where alcohol treatment and care services are key."

Addressing the price and availability of alcohol through legislation are consistently recognised as effective, public health interventions and The Salvation Army continues to encourage other Governments to learn from Scotland's approach. The Salvation Army hopes to see the Scottish Government continue with this policy and help develop a lasting legacy in supporting people experiencing harm through alcohol.
